5. Brand Compliance:

- ATPs and instructors must adhere to all AAPSCM® brand guidelines and policies.

6. Issue Resolution:

- ATPs must maintain a documented process for resolving student or customer issues.

7. Legal Entity:

- Organizations must be legally registered business entities that are active within their country and region.

8. Performance Standards:

- ATPs must pass a background check for performance, ensuring a minimum of 40 students monthly, as agreed upon in the partnership.

9. Instructor Expertise:

- Instructors must have demonstrated knowledge, education, or experience in procurement, supply chain, or tourism management to teach AAPSCM® prep courses effectively.

10. Timely Fee Remittance:

- ATPs must ensure the remittance of fees (course materials, practice test questions, and exam fees) at least two weeks before the exam date to allow for administrative checks and balances.

CHAPTER PROGRAM REQUIREMENTS FOR AUTHORIZED TRAINING PARTNERS (ATP)

To maintain transparency and avoid conflicts of interest, AAPSCM® has established the following guidelines for chapters that wish to become Authorized Training Partners (ATPs):

Conflict of Interest Management

1. Separation of Roles:

- Chapters that become ATPs may not allow individuals in training charter roles, chapter management, or decision-making positions to serve as ATP-certified instructors or ATP owners.
- Similarly, ATP owners and instructors are prohibited from serving as chapter leaders or decision-making volunteers within the chapter while maintaining their ATP status.

Training and Certification Guidelines

2. Request for Proposal (RFP) Process:

- Chapters requiring certification exam prep training must follow a formal RFP process to identify and engage an Authorized Training Partner.

3. Delivering Exam Prep:

- If a chapter wishes to provide AAPSCM® exam prep training directly to its members or students without partnering with an ATP, it must join the Authorized Training Partner program to become eligible.

4. Instructors from Non-Authorized Partners:

- Chapters that are ATPs cannot recruit or select individuals from chapters that are not ATPs to serve as certified instructors on their behalf.

Program Restrictions for Authorized Training Partners (ATP)

To maintain quality and consistency in exam preparation, AAPSCM® has established the following restrictions for Authorized Training Partners (ATPs) regarding self-paced and on-demand content delivery:

Restrictions on Self-Paced Offerings

1. AAPSCM® Exam Prep Materials:
